1 Apologies

2 Minutes of last meeting

These were approved. Matters arising:

• Unite produced a document regarding the role of the unions and summarising the recognition agreement for line managers. This is to go to the informal meeting with HR, and ratified at June JCNB.

• Comms to UCU members. Agreement to start more regular comms to members highlighting the committee's work monthly, and publicising the drop in sessions.

JS requested a more formal structure to the open discussion at the AGM following last year at which several resolutions were raised at the meeting without prior notice.

4 UCU Congress 2015 Report

MP and RC attended. A fuller report will follow on the blog. Business of the HE Sector Conference was unfortunately curtailed by overrunning debate and several motions critical of NEC were not moved due to lack of time. However two important areas of discussion included pay, pensions, and annual increments. Conference voted in favour of motions to reject performance-related pay and attacks on the National Framework Agreement; to challenge the methods used to calculate the USS deficit; and a recommendation to reject the 2015 pay offer (among many others, see http://www.ucu.org.uk/index.cfm?articleid=7524).

Action: MP and RC to prepare a report for the blog.

5 ARQM update

Following implementation of ARQM, a call for feedback from members, and discussion at Senate, KS, RC, CF and MP met with John Fothergill and Peter Brooks in May to voice concerns and share academic staff feedback on ARQM with a further meeting to be arranged to move forward on how the review will be conducted and drafting of an appeals process.

RC noticed that this issue has galvanised academics. Caution was noted on the way senior management is likely to engage on this issue and the potential wide-ranging impact of ARQM – its impact on promotions, appraisals etc. which fall outside the remit of Research and Enterprise.

7 Cass School Meeting 3rd June and Recruitment Opportunities

SB raised the issue of postgraduate students being paid in three instalments for a year's work and that this incurs increased tax deductions.

MP was glad to inform the committee that SB is standing as Research Students' Rep for 2015-16.

Action: SB and JS to meet to discuss taking forward SB's case as a test case.
